



matters of IFUNA during the year. Mr. Srivastava also thanked Mr. Bharat Babbar for doing good work in the Haryana UN Association as Secretary General and also as Addl. Secretary General of IFUNA he has given great contribution.

Mr. Srivastava welcomed the Life Members, Annual Members, Affiliated members of UNCIY and National Federation of UNESCO Associations in India who have come to attend this meeting.

In this meet, various professors from Germany were present and it was hosted by the German UN Association. I and Mr. Ram Niwas Mirdha were specially invited to attend the conference on behalf of





subjects. Mr. P C Sinha and I spoke on various subjects and all the contributions made by us were greatly appreciated. About 54 countries participated and there were more than 154 delegates from all over the world. The conference was inaugurated by Mr Ban-Ki-Moon, the Secretary General of the World Federation of United Nations and the chief guest was the Prime Minister of Korea, with the foreign minister of Korea also being present. That was a great event of WFUNA was organised in Seoul, Korea and I had the opportunity and privilege to become the Vice

Chairman of the World Federation of UN Association.

The Secretary General after presenting his report left the floor open for the state UNAs to offer their comments on the report. He asked them to give free and fair comments on the working of IFUNA and suggestions for improvement in the working of IFUNA.

In response to the Secretary General report Mr. Sita Ram Sharma said that he was very happy about the work done by IFUNA taking the organisation to new heights of success during the last three years. He also congratulated Mr Suresh Srivastava on his election as the Vice Chairman of World Federation of UN Association. Further added that by now Mr. Suresh Srivastava has become an expert in elections and we should look forward to bigger elections in the country. He make a humble suggestion that in the next National Council Meeting, when the Secretary General's report is submitted, he would be really thankful if the report covers main important programmes carried about by the state UN Associations. It would be a good idea if the national Secretary General issues a circular to all the state UNAs and they submit their report of activities for the last three years, so that the same is also circulated along with the report of the national Secretary General. We are organising some of these programmes with some international agency; we can pass on that knowledge and information to other state UNAs. I would like to specifically mention about this one particular programme here. For the last fourteen years, we have been organising inter-school debates on refugees jointly with the United Nations Human Rights Commission for the region. This is an issue on which the UNHCR is very keen to spread the message of the right of the refugee. We shall be very happy if similarly, the other state UNAs also organise these programmes jointly with UNHCR in their states and here I am sure our President Mr. P C Sinha and Mr. Amalesh Das Gupta, Secretary General would be more than willing to provide you all the necessary information as to how to go about it and for these programmes, a token of grant would also be given for organising these programmes.

I am very happy that Bharat Soka Gakkai has joined hands with our national body."

Mr. Narayanan, Secretary General, Tamil Nadu UN Association suggested "in this world of technology, where the world is shrinking with the Internet, I suggest that each state should also have a page or a website in the IFUNA; of course I will be very pleased to help you on that. Similarly, Institute of self help is another suggestion I have. As we have spoken about the world shrinking, we also need to think globally and act locally; I would recommend that you should allocate maybe a lakh or rupees every year to carry out activities as done in rural India. We could see if something of that sort could be sponsored. If we do that, we really will create prosperous states and a powerful India which can play its role in the world affairs."

Justice Shambhu Nath Srivastava from UP UN

Association said that he is associated with this institution for the last several years when he was a lawyer; "thereafter I was elevated as a judge and now I am retired. I have been invited to such a gathering for the first time. Mr. Suresh Srivastava has already appointed ad the national team has already appointed the state Secretary General in Uttar Pradesh. Now the entire team will be under the process of the constitution and within few months, the entire team of Uttar Pradesh will be constituted and some good functions will be organised there, of which you will be informed."

Advocate Ashraf Ahmed Shaikh from Maharashtra UNA said that he has two suggestions to make - IFUNA is that youth organisations across the state of the affiliated UNAs should be asked to strengthen youth bodies simultaneously with state UNAs, second suggestion is tying up with the educational institutions; the UNAs with educational institutions.

Mr. P M Parvatiyar, Secretary General, Bihar UNA said that since the chairman has stated that there is little time so I would put forth only two points. First of all, I congratulate Mr. Srivastava for presenting this elaborate report and also on his election as the Vice Chairman of WFUNA. I have got two suggestions:

- (1) "Each state unit affiliated to IFUNA should also get some funds; we will pass a resolution and IFUNA should recommend that resolution to the Ministry of External Affairs. As far as I remember, the Minister of External Affairs Mr Krishna was also in the Karnataka UNA; he even agreed to be the President of Karnataka UNA. I think he will consider our proposal; they are giving certain grants to IFUNA; that grant should be enhanced at least by rupees one lakh every year for state UNAs, as otherwise, this organisation will remain confined only to metro cities like Mr. Syed's UNA in

Dear Friends and Colleagues,

September has been an historic month for the United Nations. More Heads of States than ever before gathered at UN Headquarters in New York to discuss and debate the most pressing issues for the international community during a time of interconnected crises. The UN Climate Change Summit, which heard a remarkable statement by a young Indian girl representing the voices of the next generation of leaders, succeeded in spotlighting the urgency of action on global warming and mobilizing political will towards this end. At the special Security Council Summit chaired by U.S. President Barack Obama, a resolution calling for nuclear disarmament was unanimously adopted.

Just a few weeks before the opening of the General Assembly, WFUNA held its 39th Plenary Assembly in Seoul, Republic of Korea where 122 participants from 49 UNAs representing every region of the world attended, including a sizable delegation from IFUNA. The Plenary Assembly, chaired by Dr. Hans Blix, elected its officials, including our new President, Park Soo Gil from Korea. I congratulate once more IFUNA Secretary-General Mr. Suresh Srivastava, a long-standing member of the Executive Committee, who was elected as Vice-Chair of the Committee. WFUNA's Global Citizen Campaign was endorsed by the delegates, and the Seoul Declaration and several Resolutions were issued, which will serve as the guiding policy documents for the organization's work in the next three years.

Undoubtedly, IFUNA has chosen a very important and symbolic time to hold your National Council Meeting. I expect this meeting to provide momentum for continuing the excellent work that IFUNA has been doing over the years. I urge you to take into consideration the outcomes of the UN General Assembly and Summits, and the WFUNA Plenary Assembly, in your deliberations. I wish you success in electing your National Council for the term 2009-2012 and look forward to working together with your officials. I anticipate receiving the report of your meeting.

I would like to congratulate IFUNA on this momentous occasion and send my best wishes for the proceedings.

Mumbai and Mr. Sitaram Sharma's UNA in Calcutta. They can generate funds, but we in Bihar and similarly Mr. Patnaik in Orissa won't be able to generate much funds. I feel that we should get at least rupees one lakh as an administrative ad-hoc grant from the Ministry of External Affairs through IFUNA. We have tried hard to get financial support from state government; Mr. Mirdha too has put in efforts, but state governments have little interest in the United Nations, unless and until they get funds from the UNDP or other projects.

- (2) The other point I wanted to make about our internal affairs is that I feel the members' delegation going abroad should be rotated from state to state. The delegates we send from IFUNA should be rotated; at least every state should get a chance to send their delegate."

Mr. Biraj Sarma, Secretary General of the UNESCO Association, Guwahati said "for the last twelve years. He have done a very good job in Universities and have carried out all the programmes of the United Nations and other organisations very successfully. We have already submitted a report to the Secretary General about our activities in the last 12 years. We have been invited to this meeting for the first time as observers and are very grateful to IFUNA for having invited us for the same. I have seen the report of the Secretary General for the last three years and the Chairman of IFUNA, Mr. Mirdha, a former minister and a much respected person have done a very good job; we are very impressed. I now request that the UNESCO Association, Guwahati body should be registered with the United Nations because we want to do something under the guidance of Indian Federation of United

Nations Associations in our state too. We are registered under the United Nations, but not under IFUNA. I request all the delegates and foreign bodies to kindly register our organisation in IFUNA so that we can come and work in our state."

Mr. Sasthamangalam Mohan, Secretary General, Kerala UN Federation said "As far as the Kerala UN Association is concerned, we have, under the guidance from both the Secretary General and the President, from time to time, been monitoring our activities. Mr. Srivastava especially, has been giving us suggestions. Almost every week or in two weeks, he is in contact over phone enquiring about our activities and latest position. Both of them have attended some of our functions.

We had announced an award six months back. This is the "Worthy Earth Prize" Award to be awarded to a person who contributes to the various sectors of environment protection, in the form of a memento in addition to a cash award of Rs1 lakh.

I wish that the present leadership should continue for a longer term or till such time Mr. Srivastava becomes the IFUNA chairman. As speakers before me said, I also wish the same leadership should continue and if there is an election, we should elect the same leadership for the posts."

Mr. Amalesh Das Gupta, Secretary General, West Bengal United Nations Association said "Let me confine myself to the report of the Secretary General. The report is very comprehensive, containing 37 other reports; I know personally. This report is very good, but there have been so many other programmes. In the last three years, there were more than these 37 programmes with their reports presented; 9 states participated in these particular programmes. I don't find any report from the Madhya Pradesh UN Association. Since Assam is now going to be added, it will also come into the picture next year. I think since all the states are holding some programme or the other, we can suggest that if there is a circular from IFUNA, at least two or three programmes can be organised in all the states.

For example, observation of the UN Day, International Women's Day or Human Rights Day could be taken up. We can take at least two or three common programmes from IFUNA in a year so that all the states can have some activities throughout the year and all these reports can be sent to IFUNA. In turn, IFUNA also can guide us in organising more programmes.

A question was raised about the financial aspect. We have never faced any problem in the programmes we

are doing in our state. Of course, it is better if some funds are made available to us from IFUNA.

If the IFUNA executive committee meetings or some other meetings can be arranged in other states too, it will be beneficial for the state UNAS as well, because they will be very active and rejuvenated. This may please be considered."

Mr. A. A. Syed, Secretary General, Maharashtra UNA said, "we are all indeed very grateful to the cooperation extended to us throughout in the last 45 years from IFUNA. We have always been grateful to Mr. Srivastava who has always been guiding us in what to do, how to do, how to progress, how to organise functions, how to generate funds and how to approach people. I would like to mention here two things:

- (1) IFUNA should produce three yearly directories of all IFUNA members with all their contacts so that it should be easy for each to exchange our views, ideas and communication.

It must provide guidance on how to organise more functions. Mr. Patnaik has been doing a lot of work in Cuttack. One should be very much interested and affiliated with various social organisations. For instance, in Bombay, we are connected with more than 30 organisations and when we organise programmes, we include them, among whom are the Rotary Club, the Flying Club, Zonta International, a purely women's organisation. Similarly, there are universities like the Bombay University, SNDT University and Rotaractors who are the main life of youth activities in the Rotary Club. These people can organise many programmes. For example, in my Rotary Club, the Rotarians had organised 200 programmes this year. Though they were small programmes, they provide a model for involving the youth into the activities. Thus, in order to organise more functions and programmes, the involvement of the youth should be maximum."

Mr. Sagar Ahluwalia, Vice-president, IFUNA said "I think nobody can devote so much time as Mr. Srivastava has done it. He sleeps, thinks and talks about United Nations. I suggest we accord him an award as he has done so much work in IFUNA and has also brought so much honour to India after becoming the Vice Chairman of WFUNA.

We have talked about youth and other sessions, but one session which is missing is the session on women. We should have some special programme on women in the IFUNA as the central body. The United Nations also observes International Women's Day and we should have some programme on that basis too."

Mr. Bharat Babbar, Secretary General, Haryana UN



Federation said, "Srivastavaji initiated me to this movement. I know how he has built up this organisation to achieve ever greater heights. I endorse the view of my friends Mr. Syed and others that he should continue for the next term."

After the comments of all the state UNAs and other distinguished office bearers Mr. Srivastava thanked them for their suggestions and guidance. He further stated that he has taken note of all the suggestions made by this August house.

The audited accounts were placed by Mr.P.S.Paul, Treasurer and were unanimously adopted.

Mr. A.S. Talwar, Addl. Secretary General said "we have received nominations duly proposed and seconded by the eligible persons. There is no contest and the following persons have been elected unanimously" **(See Box, List of Elected persons)**.

Mr. Srivastava stated that we have kept a few posts vacant for the executive committee in the hope that we do not have representatives from other states of India and we would like to see all other states of India are

represented in IFUNA as we have representatives from Assam who has come as an observer, we already have confirmation from the Hon'ble speaker of the Karnataka Assembly Mr. Jagdish Shettar that he is agreeable to be the President of the Karnataka UN Association. Similarly, we have confirmation from Gujarat speaker Mr. Ashok Bhatt who would like to be the President of the Gujarat UN Association; we are in the process of the formation of the UN Association in U.P; we have confirmation from Justice S N Shrivastava from U.P. We have therefore, kept a few posts vacant in the executive committee in the hope that when these state UNAs are formed, we would be able to induct them in the organisation. With this, I leave the floor to Mr. A.S. Talwar to announce the name of the candidates for election as per agenda.
